

Registration Affidavit - Family / Economic Hardship

Parent/Guardian Affidavit

This is a legal document which must be sworn to and signed in the presence of Notary Public. If Parent/Guardian (Applicant) is married, both husband and wife must sign this Affidavit. Applicant bears the burden to provide proof sufficient to establish the existence of a family or economic hardship which renders the applicant incapable of providing support or care for the pupil. If the information provided is false, Avon School Board of Education will seek reimbursement of tuition at the current year's policy rate annually. The Avon School Board of Education will file a criminal charge against the applicant for any willfully false statement.
